SUBJECT: ROLLOUT OF EPADS UPGRADED VERSION 2.0 ACROSS FEDERAL GOVERNMENT

Dear Sir,

In continuation of this Authority's earlier communication vide D.O. letter of even number dated 1st December, 2025 on the subject cited above, and in furtherance of the Prime Minister's vision for *Digital Pakistan*, it is apprised that Public Procurement Regulatory Authority (PPRA) has developed and deployed an upgraded version of the e-Pak Acquisition and Disposal System (EPADS), namely **EPADS Version 2.0**.

2. This version incorporates enhanced functionalities, improved system performance, and a significantly better user interface. In addition, the upgraded system provides a supervisory feature enabling higher authorities in Ministries/Divisions/Departments to monitor and oversee procurement activities of their subordinate offices and field formations in real time, thereby strengthening oversight, transparency, and governance in public procurement processes.

3. It has been decided that **no new procurement activities shall be initiated on the existing version of EPADS with effect from 15th February, 2026**. Procuring agencies shall, however, be allowed to complete procurements already in progress on the existing system. **All procurement activities initiated on or after the said date, irrespective of their financial value or the method of procurement, shall mandatorily be conducted through EPADS Version 2.0.**

4. **In order to ensure a smooth transition and effective implementation of the upgraded system, PPRA has already trained over 200 Master Trainers from various government organizations during January-2026. Accordingly, all procuring agencies (including autonomous / semi-autonomous bodies and State-Owned Enterprises) working under your administrative control may kindly be directed to:**

- i. ensure their onboarding onto EPADS Version 2.0 well before the stipulated date;
- ii. submit duly completed account opening forms via email at **webhelp@ppra.gov.pk** (templates attached as [Annex-I](#) & [Annex-II](#));
- iii. contact **051-9204448** for any assistance required in connection with account opening; and
- iv. forward nominations for further trainings, if required, to the **Director (Trainings), PPRA**, 1st Floor, FBC Building, G-5/2, Islamabad (Ph: 051-9224822).

5. Your cooperation in facilitating the timely transition to EPADS Version 2.0 shall be highly appreciated.
