APPEAL UNDER RULE 48(7) OF THE PUBLIC PROCUREMENT RULES, 2004 [AGAINST THE DECISION OF THE GRIEVANCE REDRESSAL COMMITTEE (GRC) REGARDING TECHNICAL BID EVALUATION FOR SLA OF O&M AT IIAP]

The above mentioned learned counsel and representative of the respondent tendered appearance before the Appellate Committee on the day of hearing.

2. The background of the instant matter is that M/s Babar & Umar (Pvt.) Ltd. ("the Appellant") participated in the Tender No. (IIAP)/1768-03/001/ISSET/A/SLA-TENDER (MT), of Islamabad International Airport, Islamabad

("the Respondent") for the Service Level Agreement (SLA) for Operation & Maintenance of Common Use (MT) and Specialist Vehicles (SVMT) at Islamabad International Airport (IIAP). The technical bid of the appellant was declared non-responsive with a score of 42 out of 100 marks, falling short of the minimum threshold of 70 marks required for technical qualification. Being aggrieved, the Appellant approached the Grievance Redressal Committee (GRC) of the respondent on 19.02.2025, followed by a reminder dated 03.03.2025, requesting therein the detailed justification of their disqualification and re-evaluation of their bid as well. The GRC decided the said grievance on 11.03.2025, and upheld the rejection of the appellant. Hence, being aggrieved, the Appellant filed the instant Appeal.

3. On the day of hearing i.e., 04.08.2025, on Committee's call no one appeared on behalf of the appellant, however, an application of withdrawal of the instant appeal was filed by the Appellant through his counsel Mr. Muhammad Aslam Chishti on the same day.

4. On the other side, learned counsel and representative of the respondent i.e., Islamabad International Airport, Islamabad tendered appearance before the Appellate Committee and submitted that written reply in the instant appeal has already been filed by their side.



5. Upon this, the Appellate Committee perused the said withdrawal application and noticed that since the appellant no longer wish to pursue his case, therefore, the Committee *allowed* the said application dated 04.08.2025 filed by the appellant.

6. In light of the above, the appeal in hand is hereby **dismissed being withdrawn** and disposed of accordingly.
