APPEAL UNDER RULE 48(7) OF THE PUBLIC PROCUREMENT RULES, 2004

The Authority received an Appeal filed by M/s Sky link Group, through its authorised representative Syed Ali Affan (Director Exhibition) "the Appellant" on 24.11.2025 under Rule 48(7) of the Public Procurement Rules, 2004. The Authority on receipt of the Appeal issued notices to M/s Sky link Group, through its authorised representative Syed Ali Affan ("Appellant"); Trade Development Authority of Pakistan, through its Secretary; Trade Development Authority of Pakistan, through its Grievance Redressal Committee (the "Respondents"), wherein it was directed to appear in person or through their nominated representatives or Counsel before the Authority on 07.01.2026 and 09.02.2026 before the Appellate Committee in the Committee Room of Public Procurement Regulatory Authority (PPRA).






2. The instant appeal was filed against the Trade Development Authority of Pakistan (TDAP) on 24.11.2025 and was registered as Appeal No. PPRA/AP-44/2025 and the same is fixed for hearing on 09.02.2026. However, the Authority has received a written request dated 24.01.2026 submitted by the Appellant, whereby the Appellant has sought withdrawal of the above-captioned appeal. In its request, the Appellant has stated that the Board of Directors of Sky Link Distribution (Pvt) Limited has reviewed the matter and, after due deliberation, has unanimously resolved to withdraw the appeal and discontinue further proceedings. The Appellant has further clarified that the withdrawal is voluntary and without prejudice.

3. In view of the above request and as no objection to the withdrawal has been placed on record, the Appellate Committee finds no impediment in acceding to the Appellant's request. Therefore, the appeal in hand is hereby **dismissed being withdrawn** and disposed of accordingly.
